**Swopes Valley Road** – Richard Rudy made a motion to approve the request to close Swopes Valley Road, July 5, 2022 – August 15, 2022. Seconded by Shawn Hernley. All voted in favor.

Richard Rudy made a motion to accept the estimate from DK Tree Service for \$700.00 for the removal and cleanup of the marked trees along Swope Valley Road and to approve requesting a quote for the removal of the two additional trees along Swope Valley Road. Seconded by Shawn Hernley. All voted in favor.

Discussion will be held on a donation to the Pine Grove Hose and Ladder Fire Co. for helping deliver the water to the site.

**Tree Line Ave Pipe** – A revised estimate will be submitted to the township then a meeting will be scheduled with the adjoining property owners, who Chairman Hernley met with and stated they are willing to meet.

The report was forwarded to Don Consul, ConRad Consulting for review and compliance of the amount owed to the Commonwealth.

**Northern Lebanon School District – Street Light Change Request** – Richard Rudy made a motion to approve the request to revise the Met-Ed Street Light agreement to fourteen (14) light for the cost of \$28,000.00. Seconded by Shawn Hernley. All voted in favor.
