COMMENTS - Dale Snader, Snow Drive commented on the letter he submitted to the Board of Supervisors regarding the Comprehensive Plan.

ENGINEERS BUSINESS - Engineer Mack reported on the following:

Northern Lebanon School District Sidewalk - Chad Smith from Steckbeck Engineering was present to discuss the plan design and the estimated cost of the project to be approximately \$116,000. The school is agreeing to pay approximately \$80,000, which would leave a remaining balance of approximately \$25,000 to \$30,000. The Supervisors are willing to negotiate how much the township is willing to pay towards the additional cost. The township budget will have to be looked at to see how much funding would be available.

Paul and Susan Quanbeck Major Preliminary/Final Land Development Plan Time Extension Request - Shawn Hernley made a motion to accept the time extension of February 21, 2023. Seconded by Richard Rudy. All voted in favor.
